## Item 1 Liaison meeting with PCSO Lauren Drew

Mrs Hyde presented details of a specific date, Sunday June 23rd between 9am-1.30pm, when three near miss accidents involving farm vehicles were witnessed and when Douse Lane was being used by a succession of farm vehicles, groups of walkers, cyclists and a horse rider.

The Parish Council agreed to request SCC Highways to do a survey of the pinch point along Douse Lane to assess the suitability of the road in relation to the traffic which currently uses it. The PCSO advised Mrs Hyde to report to the police incidents of damage to her house and boundary wall by passing traffic, incidents which have been previously reported to SCC Highways.
